**UTILISATION OF CLUB'S FACILITIES BY ABSENT MEMBERS
(i.e. No Activation of Membership)**

- a) An Absent Member is allowed up to 2 registrations with the Club per calendar year for use of Club's facilities while in Singapore (Rule 17(h) & Bye-Law 6.5)
- b) However, Bye-Law 6.5 shall not apply to a member who is placed on the Absent Members' List on the basis that he will be away from Singapore for more than six (6) months until he has been on the Absent Members' List for at least six (6) months (Bye-Law 6.6)
- c) Each registration allows an Absent Member to use the Club's facilities for a continuous period of fourteen days only. All expenses incurred will be charged accordingly.
- d) Upon registration, temporary membership card/s will be issued. Also 4 golf vouchers will be issued by Golfing Department to each Absent Principal Member for use of Golfing facilities. Each voucher entitles the Member (or his family member) to one round of golf.
- e) For use of Club's facilities, member is required to produce the temporary membership card.

CLUB RULE 17

- (a) Subject to and in accordance with the provisions in the Bye-Laws, any member who: (i) intends to work, study or reside overseas; or (ii) be away from Singapore for more than six (6) months, may apply to the Secretary to be placed on the Absent Members' List provided he has paid all amounts due by him to the Club. The spouse and children of an Absent Member shall not be entitled to visit and make use of the facilities of the Club whilst he remains on the Absent Members' List.
- (b) The member shall be liable for the full subscription in the month he is placed on the Absent Members' List and the month he is replaced on the Active Members' List.
- (c) If a member who is placed on the Absent Members' List on the basis that he will be away from Singapore for more than six (6) months is replaced on the Active Members List after less than six (6) months, he shall pay the full subscription for the period that he was on the Absent Members' List as though he had not been absent for any period.
- (d) A member being on the Absent Members' List continuously for seven (7) years or more shall be placed back on the Active Members' list for all intents and purposes of membership rights and obligations under the Rules.
- (e) As a transitional provision for this amendment, members who have been on the Absent Members' List for more than six (6) years and six (6) months from the date of the above amendment is in force will have a further six (6) months grace period before he is returned back to the Active Members' list.
- (f) A member who has been returned to the Active Members' list either by this provision or by his own accord will not be eligible to apply for Absent Members for the next five (5) years.
- (g) While on the Absent Members' List, an Absent Member shall pay the subscription applicable to Absent Members. Should an Absent Member be in arrears of his Absent Members' subscription for a period exceeding six (6) calendar months, he shall automatically cease to be a member of the Club.
- (h) An Absent Member is entitled to the limited use of the Club's facilities prescribed in the Bye-Laws.

CLUB BYE-LAWS

- 6.1 An application to be placed on the Absent Members' List shall be supported by such documents as the Secretary may reasonably require in order to satisfy himself that the conditions for placement on the List have been met.
- 6.2 Any member on the Absent Members' List shall return:-
 - 6.2.1 all membership cards, golf tags and any other indicia of membership issued to him/her and his/her family members. If such a member fails to return the cards within three months from the date his/her name is placed on the Absent Members' List, then such member shall be liable from the next calendar month (after the expiry of such three months period) to pay the full subscription and shall remain so liable until all indicia of membership are returned to the Club, notwithstanding that such member may be absent from Singapore.
 - 6.2.2 the car park label(s) issued to him/her. If such a member fails to return the car park label(s) within three months from the date his/her name is placed on the Absent Members' List, a charge as determined by the General Committee from time to time will be imposed for the non-return of each car park label.
- 6.3 Upon request, an Absent membership card may be issued to the member on the Absent Members' List
- 6.4 Absent members are not allowed to use the facilities of reciprocal clubs.
- 6.5 A member on the Absent Members' List may register with the Secretary not more than twice a year for the use of the facilities of the Club while in Singapore. Upon each registration, the member and his family members shall be entitled to the use of the facilities of the Club, subject to such limits as the General Committee may see fit to impose, for a continuous fourteen (14) day period commencing from the date of registration.
- 6.6 Bye-Law 6.5 shall not apply to a member who is placed on the Absent Members' List on the basis that he will be away from Singapore for more than six (6) months until he has been on the Absent Members' List for at least six (6) months.
